

REGULATIONS OF THE POLISH IYENGAR YOGA CONVENTION 2020

§ 1

CONVENTION

1. The Polish Iyengar Yoga Convention 2020 (hereinafter referred to as "PKJI" 2020) is organized by the Iyengar Yoga Association in Poland with headquarters in Poznań (hereinafter referred to as "SJIP") operating on the basis of an entry in the register of entrepreneurs kept by the District Court for Poznań New City and Wilda in Poznań, 8th Commercial Department of the National Court Register under the number 0000158296, an entity also entered into the register of associations, other social and professional organizations, foundations and independent public healthcare institutions, NIP: 6762244531, REGON: 356728556.
2. PKJI 2020 is open to adults who regularly practice Iyengar Yoga for at least a year, without health contraindications - capable of independent yoga practice (hereinafter referred to as "Participants").

§ 2

REGISTRATION AND FEES

1. Registration of Participants for PKJI 2020 is available from December 6, 2019 to September 15, 2020.
2. Registration for PKJI 2020 takes place only through the Participants' application form available on the SJIP website at www.joga.org.pl.
3. The condition of participation in PKJI 2020 is the payment of the entire fee for participation in PKJI 2020 via PayU to the bank account of SJIP - the organizer of PKJI 2020. The price list of PKJI 2020 is Annex 1 to these Regulations and its integral part.
4. The registration referred to in paragraph 2 and payment of the fee for participation in PKJI 2020 referred to in para. 3 of this paragraph constitutes confirmation by the Participant that his health allows him to participate in PKJI 2020 and constitutes the Participant's statement that he is aware of the potential risk of injury related to participation in PKJI 2020.
5. The registration referred to in paragraph 2 and payment of the fee for participation in PKJI 2020 referred to in para. 3 of this paragraph is tantamount to accepting and accepting these Regulations of PKJI 2020.
6. SJIP reserves the right to amend these PKJI 2020 Regulations. All changes to these PKJI 2020 Regulations shall apply from the date of their publication on the SJIP website.
7. In case of resignation from participation in PKJI 2020 after closing the registration (September 15, 2020) of PKJI 2020 Participants, the fee paid for participation in PKJI 2020 is not refundable. **After August 15, 2020 the half of the fee is refundable.**
8. Accounting document - invoice - for participation in PKJI 2020 will be sent in electronic form from the address: biuro@joga.org.pl or skelp@joga.org.pl to participants who will provide the invoice data in the registration form and agree to send it via email.

§ 3

TERMS OF PARTICIPATION

1. The participant is obliged to comply with the regulations of PKJI 2020, as well as all decisions and recommendations issued by the SJIP representative related to the organization and course of PKJI 2020. Participants are required to maintain order in the changing rooms and the exercise room.
2. Participants are required to arrive at the place where PKJI 2020 takes place for a minimum of 30 min. before the start of the first class to receive an assignment to the sector in the exercise room and receive information materials.
Participants are required to use their own mat, 2 strips and 2 cubes during PKJI 2020.

§ 4
RESPONSIBILITY

1. SJIP is not responsible for any items left at the premises of the PKJI 2020.
2. SJIP is not responsible for any injuries or accidents of PKJI 2020 Participants.

§ 5
PARTICIPANT OBLIGATIONS

1. During PKJI 2020, it is strictly forbidden to bring, consume, use and remain under the influence of alcoholic beverages, drugs and other intoxicants.
2. During PKJI 2020 there is an absolute ban on:
 - smoking and using electronic cigarettes;
 - bringing food into a non-designated area;
 - bringing any glass objects in a non-designated area;
 - bringing any hot drinks into a non-designated area;
 - Participants wearing jewelry, decorations in the form of chains, bracelets, etc.
3. Each participant of PKJI 2020 is obliged to behave during PKJI 2020 in an appropriate manner so as not to disturb other participants. The use of vulgar or offensive language is not allowed and may result in the participant being asked for by a SJIP representative. If the participant commits behaviors that threaten the safety of other participants of PKJI 2020, in particular due to aggressive behavior or other behaviors that are against the law or principles of social coexistence, a representative of SJIP has the right to ask the participant from PKJI 2020.
4. Participation in PKJI 2020 is tantamount to the participant giving free consent to record the image of a PKJI 2020 participant with the participation of other participants on 26-29 March 2020 in the form of audiovisual recording and photographing. The above consent covers the performance of registration and reproduction of the recorded recording containing the participant's image and the free use of the recording through any medium, without territorial, time and number of transmissions, in whole and in fragments - for public reproduction of PKJI 2020, its promotion, archiving, and SJIP advertising and for other purposes related to the dissemination of Iyengar Yoga - in accordance with applicable law, including internet broadcasts / retransmissions. At the same time, the participant waives the rights related to the control and approval of each use of the registered material with his image.

§ 6
PARTICIPANT'S DATA

In accordance with art. 13 section 1 and item 2 of the General Regulation on the Protection of Personal Data of April 27, 2016 (hereinafter referred to as GDPR), we inform you that:

1. The administrator of your personal data is the Iyengar Yoga Association in Poland with headquarters in Poznań, address: 61-502, ul. M. Langiewicza 2/5.
2. Your personal data will be processed for the purpose related to the organization of the Polish Iyengar Yoga Convention 2020 organized by the Iyengara Yoga Association in Poland, as well as to issue a certificate of participation in the Convention, pursuant to art. 6 clause 1 point and GDPR.
3. The recipient of your personal data will be persons authorized by the Administrator to process data as part of performing their official duties and entities to whom the Administrator orders the performance of activities which involve the necessity to process personal data (processing entities).
4. Providing personal data contained in the form is voluntary, but also necessary to enter the list of participants of the Polish Iyengar Yoga Convention 2020.

5. Your personal data will be stored for a period of 5 years from the end of the calendar year in which you participated in the Polish Iyengar Yoga Convention 2019.
6. You have the right to access your data and the right to rectify, delete, limit processing, the right to transfer data, the right to raise objections, the right to withdraw consent at any time without affecting the lawfulness of processing based on consent before her withdrawal.
7. You have the right to lodge a complaint to the President of the Office for Personal Data Protection, if you feel that the processing of your personal data violates the provisions of the General Regulation on the protection of personal data of April 27, 2016.
